## Rules and Regulations.

### (Competitive Category)

- The subject of the entry should be on environmental awareness or wildlife conservation only.
- The Short Film should be between zero to twenty minutes (including opening titles and ending credits) and the presentation between zero to ten minutes.
- If not in English the entry should be sub-titled in English.
- The film can be shot on any type of a camera and can be edited on any type of software.
- Submitted entries will not be returned under any circumstances.
- A valid email id & other contact information must be provided to the organizers. Organizers will not take any responsibility of lack of communication if this is not fulfilled.
- Two copies of the entry on VCD or DVD (for presentations) and DVD (for short films) along with duly filled submission form for each entry should be provided.
- The presentation should be in DVD, AVI, MPEG, MPG, PPT, EXE, FLV formats only. While the short film in DVD PAL format only. The entry is not in the desired format will be rejected.
- The entry should be of broadcast quality. If not the organizers have the right to exclude it from the screening.
- Title of the entry, name and of valid contact details of the representative should be present on the DVD / VCD.
- Copies of the entries will be needed for archival purposes and hence will not be returned.
- There is no entry fee.
- The representative should be a cast or crewmember of the entry in consideration.
- In case of entries via courier, organizers will not be responsible of damages caused during transit.
- May any disputes or controversies arise due to the film/presentation the organizers will not be responsible for the same.
- All the fields in the form are mandatory and a form will be considered incomplete if any of the fields is left incomplete.
